# Training Philosophy and Playing Time

- ❖ All players are trained in all skills of the game: Passing, Serving, Setting, Hitting, Digging, Ball Control
- ❖ Teamwork skills are taught and emphasized
- ❖ Sportsmanship skills are taught & emphasized
- ❖ Positional play is introduced in the older levels
- ❖ All players will play in every match (usually matches are 2 out of 3 sets), except in the case of unusual circumstances

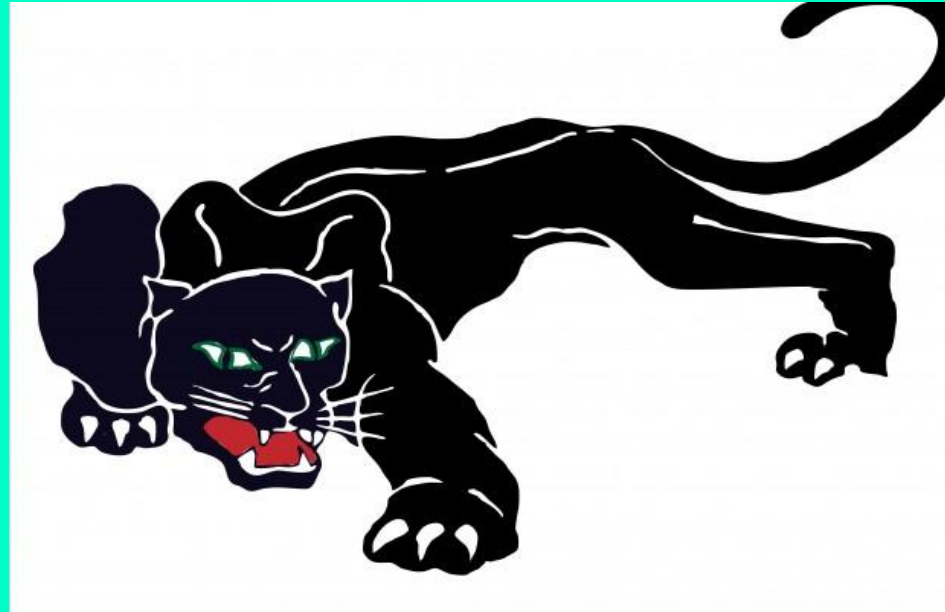

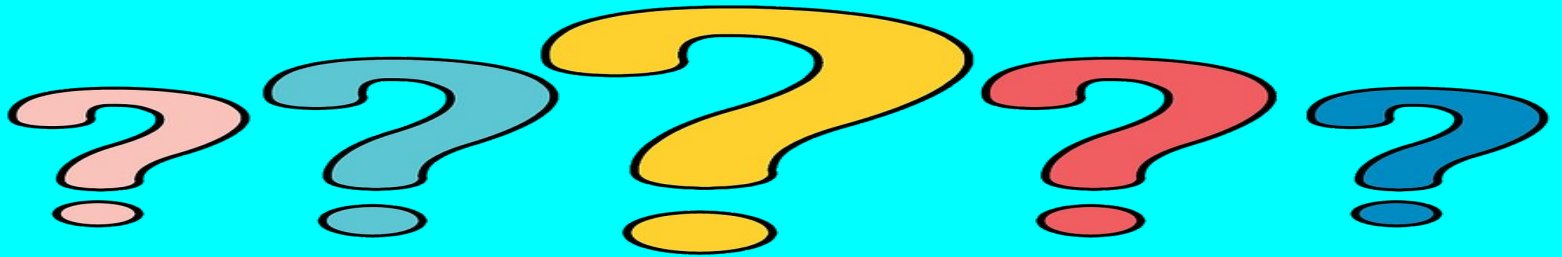
